To USARS Club Members Holding "B" or Higher Figure Skating Commissions

The USARS Judges Committee will present its recommended roster of compensated and non-compensated judges and alternates for the 2010 U.S. Figure Skating National Championships to the USARS Board of Directors at its Semi-Annual meeting in Spring 2010. Obtaining Board approval at that time will assure that all selected officials may be informed early enough to allow them prior planning for the 2010 National Championships to be held in Lincoln, Nebraska. The dates for the Figure Skating Championships are tentatively July 25, 2010 – August 8, 2010 - subject to change once the schedule for the revised format has been established.

Any official qualifying according to the following criteria should fill out the application on the reverse side (or a letter including all the information requested herein) and return it to USARS National Headquarters, P. O. Box 6579, Lincoln, NE 68506, **to arrive no later than December 1, 2009.**

Eligibility

1. You must be a USARS member in good standing.
2. You must have held a "B" commission for at least one year.
3. You must be certified as having viewed the video tapes under supervision. You must provide written proof of certification, which may be supplied by the Regional Upgrading Committee for certification.
4. You must have been an invited judge at:
 - (a) a qualifying companionship or;
 - (b) an invitational meet with all "official" events with contestants from at least three regions or;
 - (c) participated in the trial judging program at the National Championships.

When the above criteria has been met, the candidate is eligible to apply to judge the National Championships. Any registered coach who meets the above criteria may apply so long as he/she agrees not to perform any coaching services during the competition.

Applicant must be certain that he or she will be available, if accepted for the compensated panel, for the full length of the meet or part of the competition, as indicated on the front of this application.

IMPORTANT -- PLEASE READ CAREFULLY: All individual applications must be received at national headquarters in Lincoln, Nebraska by December 1, 2009. Late applications will not be considered. Applicants selected for the National Roster will be notified as soon as possible following the Spring Board Meeting in 2010.
